

MINUTES OF MEETING OF JUNE 4th. 1920

The spring meeting of the Peoples Institute was held at the office on June 4th., Mrs Corbett in the chair. Members present- Mrs Mrs Rockey, Mrs Kerr, Miss Prichard, Mrs Shevelin, Mrs Johnson and Mrs Whiteside.

Minutes of the Febreuary meeting read and approved.

Treasurers report read, showing balance on hand\$2452. It was approved.

Mrs Whiteside reported for the Finance Committee, that receipts since the last meeting amounted to a total of \$810- this , covering March, April and May donatuons; and that total received since the first of the year, a period of five months, equaled \$2430.60

The Directors report was read. Miss Prichard showed that much work had gone on, though somewhat curtailed by her illness. Three new clubs of Girl Reserves have been organized by Mrs Davis at the Shaver School, helped by the Y.W.C.A., a total of fifty girls; while as many Boys have been formed into a Military Club. Mrs Davis has made visits with a Committee from the Daughters of the American Revolution. Through this, she has accomplished getting many men to take out naturalizatuon papers. They have formed a class for learning English and done other Americanization work.

An Infant Welfare Associatuon has been formed and is ready to begin work as soon as the nurse arrives, the nurse to be furnished by the Visiting Nurse Assn.

The Community Center Work has gone on well. Gymnasium classes have been organized and other activities organized in nearly all the School Centers. A new line of work has been undertaken together with the Red Cross consisting of classes for Home Nurseing and Hygene in different School Districts.

The report of the Dispensary for the month of May shows that 655 treatments were given, 226 new patients received and a total of 364 patients seen. In the Tuberculosis clinic, 126 patients were treated.

Miss Prichard spoke of the desire of the Dispensary for an XRay. The cost would be \$1700, of which the Visiting Nurse Assn. will give \$250, the State Tuberculosis Assn/ \$250/ the City \$700, etc.. We are asked to give \$250 as our share. The expense of running it, to be covered by the University of Oregon Medical School.

The present arrangement of rent for our offices is unsatisfactory as we have no lease though the rent has been raised fro \$50 to \$75 and recently to \$100 per month.

The urgent need of new awnings was mentioned.

The University of Oregon has asked our help in the Survey they are making of delinquents, dependents etc. We are complying by having students from the School of Social Service filling out investigation cards here at the Dispensary from the patients cards which we keep on file. They will go over the 7000 cards registered in the last year

The Disectors report was approved.

It was moved and seconded that we pledge ourselves to the sum of \$250 for the XRay, taking money temporarily from our treasury and replacing it in the fall. Part of this might be met by the sale of our looms and stereoptican and the rest by an entertainment.

Moved and seconded that Miss Prichard be authorized to get the necessary awnings.

Moved and seconded that a committee of Miss Prichard, Mrs Rockey and Mrs Whiteside confers with the owners of our offices and ask that we may have a lease for as long as possible.

Meeting was adjourned until September.
