The Tuberculosis Department of the Dispensary is under the Supervision of the Visiting Nurse Association.

The Dispensary furnishes free rent, heat, light, telephone, and janitor service, also free X-ray plates for patients who cannot pay.

The Visiting Nurse Association receives \$9000.00 per year from the City for the Tuberculosis work.

The State Health Board pays to the Free Dispensary \$540.00 per year for the rent of one room to be used for the Venereal Clinics.

It also pays the salary of one special secretary for the women's division of the Venereal Clinics and a small salary to one clerk and two technicians for the Men's division of the Venereal clinics, also one half of the salary of a nurse for the Prenatal Clinic. These salaries amount to approximately \$3000.00 per year.

The State Health Board furnishes approximately \$150.00 in free drugs for the Venereal Clinic.
